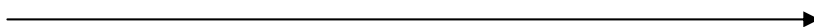

LIVONIA PUBLIC SCHOOLS STUDENT INTERNET ACCESS POLICY

Students in the Livonia Public Schools Shared Time Program at Northville Christian School will be provided, with parent and guardian approval, access to network resources for educational purposes. This access to the Internet is designed to assist in the collaboration and exchange of information, to facilitate personal growth in the use of technology, and to enhance information gathering and communication skills. This use of the Internet provides limited access.

Students must comply with the following acceptable use of the Internet for Livonia Public Schools.
